GETTING STARTED

GAME PACKAGE CONTENTS

- (1) Touch-IT Dedicated Cabinet
- (1) Touch-IT Manual
- (1) Bill Acceptor Manual
- (1) Power Cord
- (1) 14 ft. Telephone Cable

RECOMMENDED SUPPLIES

Normal telephone outlet that connects to a regular outside line.

Inexpensive telephone, used to test the line connection. Strong padlock and cable for securing cabinet to location.

QUICK START

In order for the Touch-IT unit to operate in coin mode, the unit must first be registered. This requires access to a regular, analog telephone line when the machine is registered. Failure to register the machine will result in a free-play operation only.

THE CABINET

Cabinet Keys

NOTE This requirement does not require the unit to operate as an "online" tournament game. This registration process is used to configure your unit for compliance with state requirements.

- Locate the cabinet keys attached to the cable clamp on the back of the unit and open the rear service panel.
- 2. Make sure all connections are secure.
- 3. Connect the phone line from the modem to the phone jack.
- 4. Replace and secure the rear door.
- 5. Connect the power cord and plug in the unit.
- 6. Turn the power switch to the ON position.
- 7. Press the Calibrate button behind the cash box and calibrate the monitor using the on-screen test.
- Use your ITNet Operator ID card to register the game to ITNet.
- 9. Locate the Operator Adjustables button (inside the cash drawer) or use your Operator ID card (once registered) to enter Operator Test Mode.
- 10. Adjust your game to comply with any legal restrictions in your local ordinances.

The keys to your cabinet are attached to the back of the cabinet near the Power switch. Use these keys to open the cash drawer and service panel.

Service Drawer

Remove the phillips-head screws and unlock the rear service panel and loosen the hold-down screw. Remove the cable assemblies. Carefully slide out the electronics tray. Make sure all components and connections are secure before applying power.

Your Touch-IT cabinet has been checked at the factory prior to shipping and should be ready to plug in and play. However, connections or components may come loose during shipping. Make sure all of the connectors, wires, harnesses and cables are seated securely in their sockets before applying power.

Power Requirements

Touch-IT requires a 250 Watt ATX Power Supply. It is always best to check your voltage output for best results. Verify the voltage selector switch is set to match your local AC line voltage.

Hard Drive

Touch-IT uses a hard drive to store its game data. Make sure the hard drive is mounted securely and the power and data cables are in place.

The hard drive is shipped with a mounting bracket already attached. The bracket protects the hard drive from damage due to improper handling.

CAUTION!

Hard drives are sensitive to both physical and electrical shock. DO NOT DROP the hard drive. Avoid shocks and other electrical discharges. DO NOT REMOVE the mounting bracket from the hard drive. Removal may cause damage to the hard drive and will void the warranty. Failure to use the supplied shipping box will void the warranty.

Hard Drive Returns

An approved shipping box is required when shipping a Hard Drive. Shipping boxes can be attained from Incredible Technologies. If you order a new hard drive, use the same box and packing materials to send the original hard drive back.

NOTE!

Ship the bracket with the hard drive. Do not remove the bracket from the hard drive. Failure to use the supplied box, or removal of the bracket will VOID THE WARRANTY on the hard drive.

Monitor

Your Touch-IT cabinet comes equipped with a digital hiresolution monitor, offering superb graphics and brilliant colors. Make sure your monitor is adjusted properly for best game play results. Locate the five buttons on the monitor chassis to adjust the monitor. Use the built-in monitor diagnostics to properly align the monitor.



Touch Screen

The MicroTouch™ touch screen offers superior sensitivity and player feedback. Make sure the touch screen is calibrated properly for best earnings potential. It is recommended that you calibrate your touch screen after every collection.

NOTE!

Do NOT use Windex or any other cleaning solvent that contains acid-based chemicals. These types of cleaning products will destroy the traces embedded in the touch screen glass. Use water or rubbing alcohol ONLY to clean your game. Be sure to warn the location staff of this important requirement.

Card Reader

Your Touch-IT cabinet contains a card reader unit that is installed in the front of your cabinet. Players and operators use the card reader for access to exciting online game features. Use the Card Reader test in Operator Test Mode to make sure the card reader is working properly.

Operator Adjustable and Calibrate Switches

Your cabinet comes equipped with two buttons mounted behind the cash drawer.

The Operator Adjust button activates Operator Test Mode, to access software audits, game adjustables, and system tests. Refer to the Operator Test Mode section of this manual for more information.

The Calibration button begins a test on your monitor to help you adjust the touch-screen to read player inputs properly.



Security Chain Loop

Touch-IT comes with a heavy-duty security loop, for use with a strong cable and padlock. Use this anti-theft device if you wish to secure your machine to the location. The Security Loop is shipped facing in on the cabinet back. Unplug the unit from the AC cord. Remove the 6 screws from the AC panel. Remove the 2 nuts holding the security loop, and reverse it so the loop faces outside of the cabinet. Securely replace and tighten the nuts. Replace the AC panel and re-install the 6 screws. Use a strong cable and padlock (not included) to lock the machine in place.

CONNECTING THE PHONE

LINE

In order for your Touch-IT to receive online features, you must connect it to a regular telephone line. ITNet requires a regular phone line that gives a dial tone. Some internal phone systems that are not direct outside lines may not work.

- Make sure that the supplied telephone cable is plugged into the modem connector on the PCB. Thread the cable through the mouse hole on the bottom of the service door. Be sure to loop the cable through the cable clip for extra strain relief.
- 2. Connect the loose end of the cable into any existing analog telephone jack. Use a phone jack splitter if you are connecting to a jack already in use.



Connecting to the Wall

IMPORTANT!

Your machine MUST be registered with ITNet and appropriate operator papers must be on file with Incredible Technologies, Inc. or your game will not receive the ITNet play features, and will be locked onto free play mode.

NODE CONNECTIONS

If you are planning to place more than one online machine in a location, you may want to connect them together so all of the ITNet machines share the same phone line. ITNet games can be connected together and share one phone line. Even if each machine is a different game or cabinet, only one phone line will be necessary for all the data to be transferred.

Connect the first game cabinet, such as a Golden Tee Fore! or Big Buck Hunter II to the phone line following the directions from the previous section.

Next, connect a second phone cable from the second phone jack on the game's PCB to the primary phone jack on your next game cabinet. Repeat this process to connect all your ITNet games.

NOTE! Touch-IT must be the LAST game in the chain for successful calling.

INITIAL POWER-UP

Check the game inside and out for any imperfections. Secure any loose wiring or fastening hardware.

NOTE:

Make sure all assemblies are firmly attached. Anything that is not mounted securely will rattle when the game is played. This game makes use of low-frequency sounds which can cause any loose parts to rattle.

- Plug in the game and turn it ON.
- Wait for the machine to boot up. Look for anything unusual during this startup process.
- Check the picture once it appears. Adjust your monitor to get the best picture possible.

NOTE:

Proper monitor adjustment is very important. Wait at leasst 10 minutes before making any adjustments for the first time. Some test patterns are available through the game's system tests by pressing the Operator Adjust switch. Use them when making any adjustments. (See System Tests Menu).

Upon initial power-up, the game will default to Free Play, until an initialization call is made to ITNet. The initialization call uses a toll free number to determine the correct default settings for your area, and enable cash play.

Be sure to calibrate the touchscreen at power up and after each collection for optimal performance.

Try all coin switches. Drop quarters or tokens through to check the coin mechs. Insert a dollar bill into the bill validator and listen for the credits to ring up. Make sure the game is adding credits.

If you wish to automatically run a series of system tests, hold down the Operator Adjust button when you power up the game cabinet. The game will automatically perform the MAIN MEMORY, VIDEO MEMORY, PLAYER CONTROL, SOUND TEST and HARD DRIVE tests. This is a good, quick way to check the integrity of your PCB.

Note! Units fitted with mechanical coin validators use only Coin 1. Units fitted with electronic acceptors may use Coin 1 through Coin 4.

ITNET OPERATOR

REGISTRATION

Follow these simple instructions to become eligible to operate ITNet online features. If you are already a registered ITNet operator, you can skip this step.

- 1. Fill out the ITNet Debit Account Form, found in Appendix A, and open a Debit Account at your local bank.
- 2. Read and sign the ITNet Operator Agreement, found in Appendix A.
- Fax or mail these two forms to Incredible Technologies, Inc. to become an authorized ITNet Operator.

NOTE:

If you are already registered with ITNet and these forms are on file and in good standing, you do not have to fill them out again. All your ITNet games can share the same bank account.

4. Once these forms are processed, you will receive your ITNet Operator ID Card in the mail.

The Operator ID Card allows you to:

Register your games for online play right on-site.

Activate games, add and change location information, and de-activate games at the location.

Gain access to the personalized IT Operator Services web site.

Check audits and bookkeeping from your home or office.

NOTE!:

If you are a brand new ITNet operator and can't wait for your Operator ID card to arrive in the mail, you can fax the GAME REGISTRATION FORM, found in your ITNet Procedures Manual, to Incredible Technologies. The ITNet staff will then enter your machine's location data for you. Please allow 5 business days for processing. When your machine calls in, it will automatically register to your account and activate the online features.

ITNET INSTALLATION

PROCEDURE

Follow these simple instructions for game and ITNet setup.

- 1. Follow the instructions above to become an ITNet operator and receive your Operator ID card.
- 2. Set up your ITS-compatible game cabinet as you would any other video game. Refer to other sections in this manual for further help. Power should remain OFF at this point.
- Turn on the game. You may have to wait a few seconds for hard drive access. If the game is not registered a screen will appear asking you to register. Follow the onscreen instructions to properly register your Touch-IT.
- 4. If the game is already turned on you can still use your card to register your game. Enter Operator Test Mode by pressing the Operator Adjust button or swiping your ITNet Operator Card. Then from the MAIN MENU, select ITNET, then REGISTER GAME/LOCATION. Follow the On-screen instructions. Swipe your ITNet Operator Identification Card when prompted.

NOTE:

If you do not have your Operator ID Card yet, you can fax the Game Registration Form to Incredible Technologies. The ITNet staff will then enter your machine's location data for you. Please allow 2 to 5 business days for processing. When your machine calls in, it will automatically register to your account and activate the online features.

- 5. Enter all of the necessary location information carefully and accurately. When completed, the game will automatically attempt to connect to ITNet. Pay attention to the various screen messages as the game makes its call, to spot any trouble areas.
- 6. Automatic installation is successful when the screen displays a SUCCESSFUL message. If any unsuccessful message appears, the game will try again automatically in a few minutes, or you can enter Operator Mode by pressing the test button inside the coin door or swiping your ITNet Operator Card, and manually force a call. If your first few attempts to call are unsuccessful, refer to the troubleshooting guide in your manual or call your distributor.
- 7. The game is now connected to the ITNet System and ready for public play! Online features will be automatically activated by Incredible Technologies.

GAME TEST MODE

Enter Operator Test Mode by pressing the Operator Adjust button inside the cash drawer or swiping your ITNet Operator Card. Test Mode allows you to adjust certain game settings and track valuable audits and bookkeeping information.

NOTE!

The current code version number and the Board Serial ID are displayed at the top of every menu. Call-in information is displayed at the bottom of each menu, including the Local time, the next scheduled call to ITNet, the last successful ITNet call, and the last attempted call to ITNet.

MAIN MENU

The first screen displayed in Operator Test Mode is the Main Menu. The Main Menu displays the various selections available to the operator.

COLLECTIONS displays the current machine coin counts, for use in separation of ITNet fees from your collections.

AUDITS allows you to check your game's coin, play option, and lifetime audits.

ADJUSTMENTS is used for customizing the game to your location including player costs per game, high score resets, and default skins.

DIAGNOSTICS verifies the operation of the hardware, controls, monitor, sound and card reader through easy and automatic procedures accessed through this menu.

UTILITIES allows you to perform a variety of important functions, including touchscreen calibration and factory resets.

ITNET is designed to take advantage of many of the ITNet capabilities including registering your machine with ITNet, disabling/enabling calls to ITNet, and forcing a call to ITNet.

COLLECTIONS MENU

Use this screen to assist in bookkeeping when doing collections from your cabinet. This will show you the amount of money owed to ITNet as well as your portion currently in the cabinet.

This screen also displays important collection information that allows you to accurately determine your split with your location. Resetting this screen after every cash box collection will ensure the most accurate results.

LAST COLLECTION displays the date this screen was cleared last. Clearing this screen in conjunction with every collection will assure that the cash box matches the totals on this report.

TOTALS SINCE LAST COLLECTION displays the total number of dollars in the machine since the audits were last reset.

ITNET PORTION displays the amount of money owed to ITNet. Separate this amount from your collection before you make your split, if any, with the location. Deposit this amount into your debit account on a timely basis to ensure proper funds.

OPERATOR/LOCATION PORTION displays the amount of money in the machine, minus the ITNet portion. This is the amount of your collection that you may split with your location.

The **DO COLLECTION AND RESET AUDITS** button is used to erase all of the collection counts stored in memory and reset the game audits. Pressing this button will change all dollar amounts to zero, and update the Last Collection Date.

NOTE:

In order to make bookkeeping easier, all audits but the lifetime coin count will reset with each collection, making everything more synchronized. Lifetime audits do not reset.

AUDITS MENU

The **GAME AUDITS MENU** will supply you with a detailed accounting of helpful and informative bookkeeping and statistics.

COINAGE AUDITS lets you review the coin audits for the game. This will give you information concerning how many were used in the various credit modes.

GAME AUDIT TOTALS displays the totals and percentages over the all the various games that were selected by players, and how long they played.

INDIVIDUAL GAME AUDITS is a breakdown of selections and times by players for each individual game available to play. Select any of the game titles to return current play information.

HISTOGRAMS displays the total number of games played, and the peak times that the unit is played, in easy to read graphs. Select Number of Games Played to view the various games selected by players, and find out which ones are the most popular. Select Peak Times Games Played to determine when your Touch-IT unit is being played most often.



ADJUSTMENTS MENU

Use this menu to adjust and customize Touch-IT to best suit your location. The following are brief descriptions of each adjustable function and what the screen looks like when displayed.

FREE PLAY, does not require coins for play. Select ON for Free Play, and OFF for coin play.

NOTE:

If FREE PLAY is set to ON, your machine will not allow Tournament or VIP play.

COIN VALUES: Use the "+" and"-" buttons to select values for the various coins that will be used in your Touch-IT unit. The number value represents the number of pulses that will be sent to the hard meters. In the US, the common coin is the Quarter, and the default setting is 1.

THIS ADDENDUM REPLACES PAGES 11 and 12 IN YOUR TOUCH-IT MANUAL.

BILL VALUE: In the US, the factory installed bill acceptor automatically sends 4 pulses when a single bill is inserted, so this setting should be set to 1. If installing a new bill acceptor, please check the owners manual for the correct number of pulses for a single bill.

20 CREDIT BONUS: You can offer bonus credits to players who insert enough money at one time to give them 20 credits (equivilent to \$5.00 in the US). Use the "+" and"-" buttons to select the number of credits to be added. The factory setting is OFF.

GAME

The Game menu allows you to adjust various game attributes. You can select to adjust individual games, or all games at once.

GAME ENABLED determines if the selected game will be available to players. YES means it is available, and NO means it is not.

CREDITS TO START determines the number of credits needed to begin a game. The default setting is 2.

SPECIAL CREDITS TO START and **DISCOUNT CREDITS TO START** determine any special increase or decrease in price that you may want to offer to players during specific time periods. To set the actual time frames, see the LOOK AND FEEL menu.

TOURNAMENT CREDITS TO START sets the number of coins needed for an ITS tournament game. Tournaments start and end automatically, as long as the machine is registered to ITNet. Generally, tournament games are twice that of regular play, since a portion of the tournament fees are used by IT to pay tournament prizes. The default setting is 4.

If the **SELECT ALL** button is chosen, this menu will update all of the games with the adjustments selected on this menu.

LOOK AND FEEL

Touch-IT lets you customize certain visual, audio and pricing attributes to best suit your specific location.

TIMED SETTINGS allows you to create special pricing for various times of the week. For example, if you wanted to host a "Solitaire Saturday", you could set the cost of the Solitaire game to one coin less than normal, during specific hours every Saturday.

The timed settings menu determines your schedule for these specials and events. Costs for specials on individual games are set in the GAME menu.

Note:

Touch-IT offers two separate opportunities to set special pricing. If you set up special pricing for two different time periods, make sure the time periods do not overlap.

Additional Manual Changes

Adaptable "Skin" technology has been removed.

ITNet registration is now optional. However, if you are already an ITNet operator, you can still register your game and connect it to a phone line, to enjoy free Operator Services through your secure website account.

Tournament and VIP play are currently not available.

Select **CARD GAMES** to choose the appropriate graphics for your state when playing card-based games. ON means traditional playing cards will be displayed. SYMBOL DECK displays cards using shapes and numbers. SYMBOLS ONLY displays a graphic representation with numbers and symbols. OFF will disable all card games.

Touch-IT has been inspected and tested at the factory and should arrive to you in perfect working order. If you are experiencing any problems with the game, the **DIAGNOSTICS MENU** is a good place to start when tracking down the problem.

PLAYER CONTROLS

When **PLAYER CONTROLS** is selected, the screen will display a diagram of the Touch-IT inputs. The controls are highlighted on the diagram when the controls are active. Test all of the controls, including the hard meter and service switches.



CARD READER TESTS

This test checks the card reader hardware. You will see the message "SWIPE A CARD THROUGH THE CARD READER".

Swipe a card though the card reader. Normally the message "A CARD SWIPE HAS BEEN DETECTED." is displayed, as well as the recognized card type. If you do not get the message, try swiping a card at different speeds or use a different operator or player card. If still unsuccessful, contact your distributor or the IT service department.

MODEM TESTS

This menu tests the existence of the on-board modem as well as its ability to respond. Each machine needs its own working modem, even if daisy chained. Selecting this test will activate the test and a pass or fail message will appear. If the modem test fails, contact your distributor or the IT Service Department.



MOTHERBOARD

This test measures the temperature and fan on your main PCB. If the motherboard gets too hot, you may experience game failures. It is wise to check this test often to make sure the fan is working correctly and your system does not overheat.

SERVICE CREDITS allows you to add a credit without adding any money.

AD SCREEN allows you to create advertisements that are displayed in the game's attract mode when no one is playing.

CALIBRATION allows you to calibrate your touch screen for best play results. Be sure to calibrate often.

DEFAULT ADJUSTMENTS resets your entire machine to factory default settings. Be sure you really want to do this before selecting OK.

FACTORY RESET clears all audits, including financial records, and all adjustable settings to factory settings. Be very sure you want to do this before selecting OK. Once selected, you cannot go back to your audits or previous settings.

UPDATE FROM CD-ROM is where you go to install a new CD update from IT. The screen offers instructions on how to perform the update. Look in this manual for more information on compatible CD-ROM Drives.

CHANGE LOCATION PIN allows you to create a special PIN number for your location manager. The PIN number allows the location manager to make some adjustments, based on your selections in the CUSTOMIZE LOCATION menu. The default PIN is 0246.

ITNET MENU

This menu is designed for the operator to interface with ITNet at the game itself. Instant registration, quick location information changes, and changing dialing functions are available from this menu.

ITNET ACTIVE is used when you temporarily want to disable ITNet on a certain machine (i.e. to get the phone line fixed), or when you want to re-enable a temporarily disabled machine back on ITNet calling. This does not take the place of UNREGISTRATION and you will still be responsible for that machine with ITNet. It is recommended that you only disable after the machine has made a successful call to ITNet.

NOTE:

Disabling calling will deactivate your machine from the VIP Club and Tournament play functions.

If you disable ITNet and later re-enable it, a successful call in to ITNet must occur for this status to be updated.

TOURNAMENTS lets you disable the ITS tournament function on your unit. Make sure the current tournament format is allowed in your state or location.

FORCE CALL is used to make your machine manually call ITNet at a time other than its regularly scheduled hour. This can be used when you are trying to fix the modem or phone line on your machine, or if you are about to disable calling and want the last set of information to be transmitted to the ITNet servers. This setting defaults to OFF. If you select ON, as soon as you Save and Exit the machine will automatically attempt to call ITNet.

PHONE LINE TYPE: While most phones use tone dialing, some still use rotary or pulse to dial. Accidentally setting this feature to Pulse on a tone line should not effect the call to ITNet.

PAUSE BEFORE DIAL is another quick access item designed to help ensure calls get made successfully to ITNet. The number you set here is the pause it uses to wait for the outside line. This is normally only required when you use a number to dial out with first, but won't hurt the machine if you leave the default set to 2.

WAIT FOR DIALTONE allows you to tell your machine whether or not to detect a dial tone when making an outside call. When set to ON, the machine's modem will wait to detect a dial tone before dialing. When set to OFF, the machine will not wait for a dial tone before dialing. For US machines, the default setting is ON and in most cases should not be changed.

This screen displays the current ITNet registration status. If the game has been successfully registered, the messages will read: "Board is registered." If the game has never been registered, or has been unsuccessfully registered, the message will read: "This machine is not registered."

NOTE:

The new Touch-IT PCB has its own Serial number. This important number can be found at the top left corner of the screen in test mode.

NOTE:

Use your Operator ID card to register your game to your ITNet account. If you do not have your cards, please call us at 847-870-7027, x141 to order them. You can register your game in the mean time by faxing the completed Game Registration Form found in the Appendix A to IT for processing.

If you are updating location data on a registered machine, this screen will show the updated information after a successful call to ITNet. Note: If the machine is turned off before a call has been made, you will lose the new information until a successful call has been completed.

If you choose to register your machine via the Game Initialization form, send or fax it to Incredible Technologies. ITNet will try to process your paperwork within 3 to 5 business days. Make sure your machine makes a successful call to ITNet then the correct information will appear on this screen.

REGISTER GAME AND LOCATION

This menu is used to tie the game to the operator and its physical location. This is necessary for access to online ITNet features. This menu takes the place of the ITNet Registration Form. However you will still need to set up a debit account and sign an operator agreement, if you are not already a registered operator with ITS/ITNet. This menu is automatically displayed any time an unregistered machine is turned on.

NOTE:

Make sure you have your machine plugged into a phone line and your operator card ready. You will need to enter data into each field unless instructions state otherwise. Please abbreviate where necessary and read your information first before pressing YES on the field verification screens.

POWER SURGE PROTECTION RECOMMENDATIONS

To protect from lightning strikes through the phone line.

This is a less expensive solution, but will only protect damage that may come through the phone line. Protect your voice mail, answering machine, telex and fax machines, modems and other telephone equipment with the ProtectNet PTel2 model. The PTel2 provides 2-line (4-wire) telephone line surge protection. PTel2 accommodates both standard RJ-11 and RJ-45 telephone jacks and features a self-resetting fuse which makes it maintenance free!

ITNET OPERATOR AGREEMENT

If OPERATOR fulfills all its obligations under this Agreement, IT agrees to credit OPERATOR five percent (5%) of the online entry fees at each billing cycle.

5. CONFIDENTIALITY

Each party agrees that the trade secrets, technological information, marketing plans, and any other confidential business information disclosed in the course of performance under this Agreement, shall be held in the strictest confidence and not disclosed to anyone without the written consent of the other party, except by written order of a court or other legal authority with appropriate jurisdiction. IT agrees that it will not disclose information about the ITNet earnings of specific locations, or that OPERATOR has specific locations, except that IT may disclose information that a specific serial number, with no reference to a location, is earning less in entry fees to IT than the cost of local prizes and maintenance of that unit on the ITNet system. The obligations of the parties under this section shall survive the termination or expiration of this agreement for a period of two years.

6. MISCELLANEOUS

The validity and construction of this Agreement and of the rights and obligations herein shall be determined and governed by the laws of the State of Illinois. The parties agree that any and all disputes or litigation related hereto, shall be resolved in the state or federal courts within Cook County, Illinois.
