# USER GUIDE

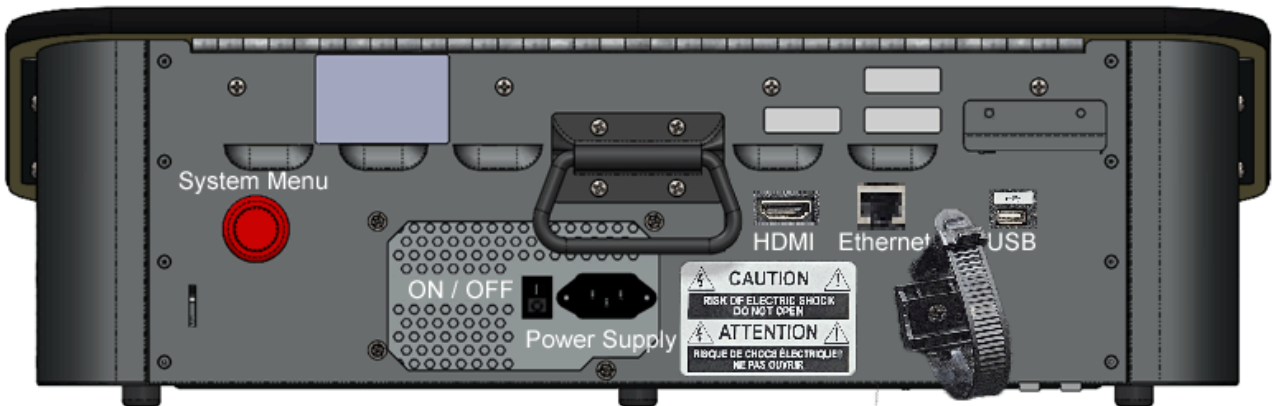

### Quick-and-Easy Setup

1. Connect the HDMI cable from the rear of the GO cabinet to a 4K HDTV.  
**Note:** The game requires a display with a 4K resolution.
2. Connect the power cable to the Power Supply input on the back of the GO cabinet, then to a grounded power outlet.
3. Turn ON the 4K HDTV. On the HDTV menu, select the appropriate HDMI Input. (Your HDTV may automatically sense the input when powered ON.)
4. Locate the power ON/OFF switch on the back of the cabinet and turn it ON.



### Online Subscription

You can purchase a monthly or a yearly subscription to get your game online. You'll get access to online contests, exclusive game modes, special events and more. ### Online Access

Once subscribed, you can access online features by bringing your GO cabinet online via Dedicated Ethernet or WiFi Adapter.

### Dedicated Ethernet

If your cabinet is near your computer internet connection point (router and modem) do the following:

1. Plug in the Ethernet cable to the Ethernet port on the rear of the GO cabinet.
2. Plug in the opposite end of the cable to the Ethernet port on the router.
3. Turn ON power to the cabinet.
4. Access the System Menus by pushing the red button on the rear of the GO cabinet.
5. Navigate to **ITNet Settings>Communication Settings** and verify that your connection is Ethernet. Your last IP address should display if the game is connected.
6. Choose **Configure Ethernet** and then **Test Ethernet**. If the settings are correct a connection attempt will be successful.

### WiFi Adapter for Wireless Network Connection

Connect the USB Adapter to the rear of the GO cabinet.

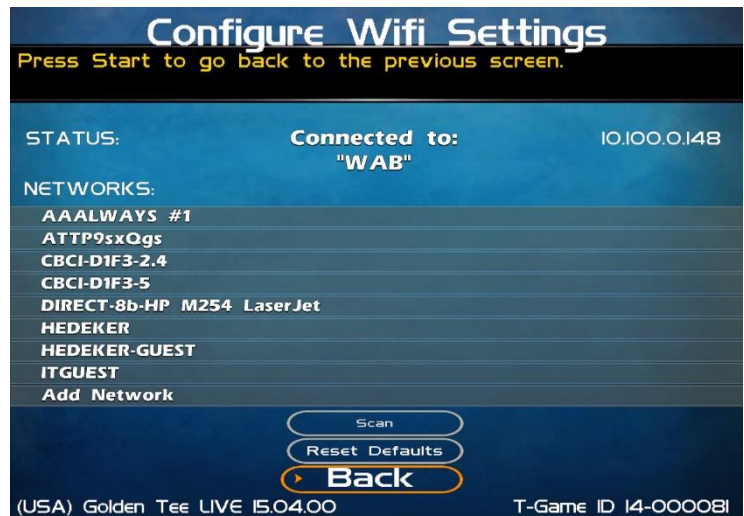
#### Requirements for configuration

- The location must have an available WiFi Network/Hotspot.
- The **Network/Hotspot Name** must be known.
- The **Network/Hotspot Password** must be known.



#### WiFi Adapter and Settings Configuration

1. Make sure that the GO cabinet is OFF before starting.
2. Plug the USB Adapter into the USB port on the rear of the cabinet.
3. Turn ON power to the cabinet.
4. Once the game boots to the attract screen, access System Menus using the red button on the rear of the cabinet. Use the trackball to navigate to **ITNet Settings>Communication Settings**.
5. Select **Configure Wifi Settings**. Select **Scan**. The game scans available Networks to find yours.



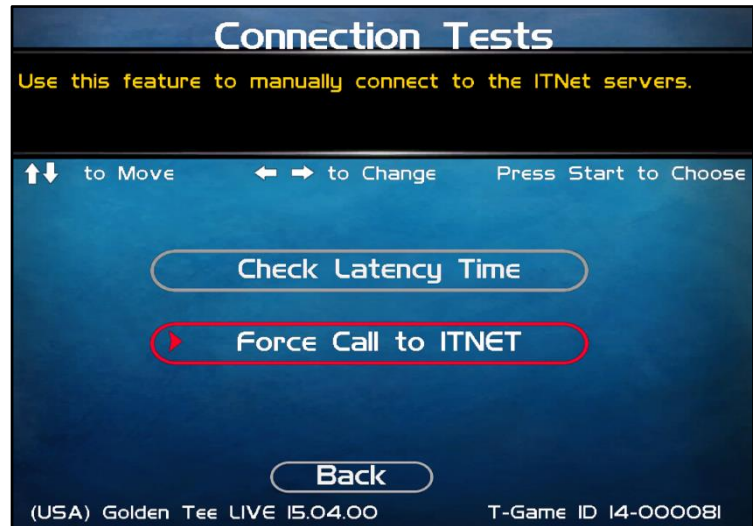
#### Configure WiFi Settings

**Note:** If your Network is not found it is possible to manually enter the name of your Network by selecting **Add Network** at the bottom of the list of available Networks.

6. Enter Password. Then select **Done**. (It will take anywhere from 30 seconds to four minutes for the game to connect to the WiFi Network.) If no connection is made after four minutes, the attempt automatically times out. In the event of a failed connection, reboot the machine. Check the USB connection and ensure that your Network is online before a second connection attempt.
7. Navigate to **ITNet Settings>Connection Tests** and select **Force Call to ITNET**.
8. Once connected to ITNET the game is online and ready for play.

## **System Menus**

System Menus allow you to adjust various game and cabinet settings and test the hardware components. Access System Menus by pressing the red button on the back of the cabinet. Be sure the cabinet is on and a game has not been started.

## **Main Menu**

**SETTINGS** – Adjust various game settings

**SOUNDS** – Adjust sounds for internal and external speakers

**SYSTEM** – Test your cabinet hardware and components

**Reset Leaderboards & Records** – Clear initials and scores from all leaderboard and record screens.

**Reset to Factory** – Reset all settings to factory defaults

## **Settings Menu**

SETTINGS

**Difficulty** – Adjust wind speeds and slope of greens for added challenge. Default setting is 3

**Timer** – Adjust the time allowed to take a swing. Default setting is OFF

## **Sounds Menu**

SOUNDS

**In Game Volume** – Adjust the sound and music volume while playing a game.

**Attract Volume** – Adjust the sound and music volume when the game is on but no one is playing

**Attract Sounds** – Enable or Disable sounds when the game is on but no one is playing

**Digital Audio** – Enable sounds from external digital speakers via connected HDMI cable (not included -- enabling this requires an automatic software reboot)

## **System Menu**

SYSTEM

**Video Tests** – Test color, contrast and screen size for the game TV

**Sound Tests** – Test the internal speaker

**Player Control Tests** – Test the trackball and button controls

**Hardware Tests** – View system hardware info and check the hard drive



### **General Maintenance**

When handled properly, your GT PGA TOUR GO cabinet should perform without issue for many years. Here are some tips to keeping your game in tip-top condition.

- Take care not to scratch the top surface. Remove rings and other jewelry when playing.
- Avoid grease, creams or oils when you play.
- Use a damp cloth to clean the play surface.
- Do not strike the cabinet or trackball with excessive force.
- Take care when transporting your GT PGA TOUR GO. Do not drop or jostle the cabinet. Excessive vibration can loosen internal connections which can cause malfunctions.
- Turn the unit off when not in use, to maximize the life of the TV screen.
- It is recommended that you keep the original box and packaging for storage and transportation.

### **Trackball Maintenance**

Trackballs can get dirty over time. To clean the trackball you will need to remove it from the cabinet. Use the following YouTube hyperlink for details on cleaning your trackball:

To access the interior of the GO cabinet, use a Phillips-head screwdriver and remove the two screws under the cover on the left of the cabinet, two screws under the cover on the right of the cabinet, and the two screws under the cover at the front of the cabinet. Set the screws aside in a safe place. You will need to reattach the screws when finished.

The cover of the GT GO PGA TOUR is on a hinge at the rear of the cabinet. Carefully lift the hinged cover to access the interior of the cabinet.

### **Standard Returns Policy**
